

MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING IS MADE ON THIS 10th DAY OF June 19, 2025, by and between Anudip Foundation for Social Welfare, having its registered office situated at Mira Towers, 8th & 9th floor, Block: DN 27, Sec-V, Salt Lake City Kolkata-700091, hereinafter referred to as the “First Party” (which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its successors and assigns, in one Part)

AND

Rishi M.S Institute of Engineering & Technology for Women (Nizam pet Cross Rd, Road No. 6, near JNTUH, Addagutta, Samatha Nagar, Kukatpally, Hyderabad, Telangana 500090 hereinafter referred to as the “Second Party” (which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its successors and assigns, in the other part).

ARTICLE 1

BACKGROUND OF ANUDIP FOUNDATION:

ANUDIP FOUNDATION FOR SOCIAL WELFARE, a company originally incorporated in the year 2007 under Section 25 of the Companies Act, 1956; currently regulated by section 8 of the Companies Act, 2013, which governs companies formed for charitable purposes. Headquartered at Mira Towers, 8th & 9th Floor, Block DN 27, Sec-V, Salt Lake City, Kolkata- 700091, the foundation aims to address socioeconomic disparities by creating and promoting sustainable livelihood opportunities. The primary objective of Anudip Foundation is to improve the economic and social status of disadvantaged groups residing in rural and semi-urban areas. This includes regions across West Bengal, Odisha, Jharkhand, Andhra Pradesh, Telangana, Tamil Nadu, Rajasthan, Maharashtra, North East India, and Delhi. Through partnerships with international and national agencies, government units, corporations, and community-based organizations, Anudip offers targeted programs designed to enhance employability and foster entrepreneurial skills. By focusing on IT-enabled job opportunities and business ventures, Anudip Foundation strives to empower individuals with the skills and resources necessary to secure stable employment and create sustainable economic growth in their communities.

ARTICLE 3

PURPOSE

The purpose of this Memorandum of Understanding (MOU) is to formalize the collaboration between Anudip Foundation for Social Welfare and Rishi M.S Institute of Engineering & Technology for Women, Hyderabad to mobilize the students for the skill development program aimed at enhancing employability and career prospects for unemployed youth and women.

This MOU outlines the roles, responsibilities, and mutual commitments of the Parties to ensure the successful execution of the program.

ARTICLE 4

SCOPE OF WORK

4.1 Program Objective:

The First Party (Anudip Foundation) will deliver market-aligned skill and career development training programs designed to prepare unemployed youth and women for successful placement in various job roles. The focus is on providing comprehensive training that includes both technical skills and soft skills essential for career advancement.

Rishi M.S Institute of Engineering & Technology for Women will facilitate the enrolment of students for the program. The Second Party is responsible for identifying and enrolling eligible candidates who will benefit from the training provided by the First Party. The Second Party is obliged under this MOU to provide 100+ number of students during the project period to the First Party.

ARTICLE 5

EFFECTIVE DATE AND VALIDITY

The effective date of this MOU shall be 10/06/2025 and remain in force till 10/03/2026.

ARTICLE 6

PROGRAM DELIVEABLE:

Rishi M.S Institute of Engineering & Technology for Women would provide eligible students to Anudip. With this collaboration Anudip aims to impart market aligned skill and career development training program for the unemployed youth and women towards successful placement of the trained students. In case of future batches, same clauses as prescribed herein will be followed. Locations preference as follows from 1st Party.

ARTICLE 7

VOLUNTARY FINANCIAL CONTRIBUTIONS

7.1. Contributions: Students may be invited to make a voluntary financial contribution up to Rs. 500 for Deeptech, depending on their financial capacity.

7.2. Purpose of Contributions: Any financial contributions made by students will be used exclusively for educational programs, scholarships, or other related activities organized by Anudip.

7.3. Receipts and Documentation: Official receipts will be issued for all financial contributions received. These receipts will specify the amount contributed, the purpose of the contribution, the NGO's details, and the date of receipt. All contributions will be properly recorded in the Anudip's financial records to ensure transparency.

7.4. Tax-Exempt Status and Compliance: Anudip is registered for tax exemptions under Section 80G of the Income Tax Act. Donations made by students may qualify for tax deductions under Section 80G, subject to availability of PAN Number of Donor.

ARTICLE 9

BENEFICIARIES' PROFILE:

Minimum age for the target group is 18 years and maximum age is 30 years. Minimum educational qualification would be from any technical domain.

ARTICLE 10

TRAINING METHODOLOGY

Anudip's digital livelihoods program follows a technology-driven, methodology that has evolved based on employer and student feedback, team evaluation, and impact studies conducted externally and internally, Anudip team continuously tries to align with changing job markets, digital trends, and the state of the training technology worldwide.

ARTICLE 11

TRAINING LOCATION:

Training will be conducted by trainers of Anudip Foundation at the premises of Rishi M.S Institute of Engineering & Technology for Women. This will be effective for Accenture Project.

ARTICLE 12

Student Exit Profile:

After successful certification, Anudip's graduates who are job-ready will get the placement assistance. The Job will be based in any part of the country depending on employer's specifications.



ARTICLE 13**FINANCIAL CLAUSE:**

Anudip will provide at the rate of **Rs. 300**(Three Hundred) per student to the Partner **Rishi M.S Institute of Engineering & Technology for Women** for enrolling approximately **150** students during the project period for Mobilization and enrolment. The amount will be paid through the Bank account provided **Rishi M.S Institute of Engineering & Technology for Women** and will be payable:

- ☐ Rs. 150 after 15 days of admissions
- ☐ Rs. 150 after certification is completed.

In case the number of enrolled students, in a month, falls below 30 then the payment for those students would be postponed to next month along with next month's payout.

The second party has to submit all the claims within the project period and no claims will be accepted after end of the project. The Invoices along with supportive documents should contain the proper details of the work done till the date of Invoice. Invoice has to be submitted within 15 days of the completion of the billable work. Standard TDS will be deducted according to the norms of Government of India.

ARTICLE 14**RELATIONSHIP**

The Parties expressly declaring that the relationship between the Parties is on a principal-to- principal basis, and no other relationship is intended, including a partnership, franchise, joint venture, agency, employer/employee, or other special relationship. Neither Party shall act in a manner, which expresses or implies a relationship other than that of independent contractors, nor bind the other Party.

ARTICLE 15**EXCLUSIVITY**

Nothing contained herein shall restrict the right of any Party herein to enter into negotiations, business arrangements, partnerships, agreements and the like with third Parties of its choice.



ARTICLE 16**FORCE MAJEURE****Definition**

For the purposes of this MoU, "Force Majeure" refers to any event or circumstance beyond the reasonable control of either party, which prevents or significantly impairs the performance of their obligations under this MoU. Such events may include, but are not limited to, acts of God, natural disasters (e.g., earthquakes, floods, hurricanes), war, terrorism, civil unrest, strikes, lockouts, epidemics, pandemics, governmental actions or regulations, or any other event or circumstance that could not have been avoided or mitigated with reasonable care.

Notification

In the event of a Force Majeure occurrence, the affected party shall promptly notify the other party in writing of the occurrence of such an event, the nature of the Force Majeure, and its estimated duration. The affected party shall use all reasonable efforts to mitigate the effects of the Force Majeure and resume performance of their obligations as soon as possible.

Suspension of Obligations

During the period of Force Majeure, the obligations of the affected party under this MoU shall be suspended to the extent they are affected by the Force Majeure event. The affected party shall not be liable for any delay or failure in the performance of its obligations to the extent caused by the Force Majeure.

Termination due to Force Majeure event

If a Force Majeure event continues for a period exceeding [Number] days, either party may terminate this MoU by providing written notice to the other party. In such a case, any outstanding obligations or payments that have accrued up to the date of termination shall be settled as per the terms of this MoU.

No Compensation

Neither party shall be liable to the other for any direct or indirect loss, damage, or cost resulting from the occurrence of a Force Majeure event.

ARTICLE 17**INTELLECTUAL PROPERTY RIGHTS**

The Parties mutually undertake that they shall not infringe and use unauthorizedly the intellectual properties right of other party save and except on the basis of consent of the other party.

ARTICLE 18**GOVERNING LAW:**

This MoU is made under and shall be governed by and constructed under the law of the republic of India under the jurisdiction of the course at Kolkata.



ARTICLE 19

AMENDMENTS:

This MoU shall not be amended, changed, modified in whole or in part except by an instrument in writing signed by both the Parties hereto. However, Anudip Foundation reserves the right to modify scope of the Program on its sole discretion on notification to Partner Institute.

ARTICLE 20

ARBITRATION:

In the event of any claim, Controversy, Dispute or differences between the parties arising out of or in connection with or in relation to this agreement either party will be entitled refer the same to arbitration in accordance with rules of arbitrators, one to be appointed by Anudip Foundation, the other to be appointed by Rishi M.S Institute of Engineering & Technology For Women and the third party to be appointed by the two arbitrators appointed by the parties. The place of arbitration shall be Kolkata. The Language of Arbitration Proceedings shall be English. The award of the arbitrators shall be final and binding on the parties.

ARTICLE 21

COUNTERPARTS:

This MoU may be executed in two counterparts each of which when so executed and delivered in the English language shall be an original, but all of which shall together constitute one and same instrument.

ARTICLE 22

General Termination:

Either party may terminate this Memorandum of Understanding by giving 30 days' prior notice for in case of violation of any essential terms and condition of this MOU.

ARTICLE 23

SIGNATORIES

IN WITNESS WHEREOF the Parties have agreed to execute this MOU as on the date mentioned hereinabove.
