**Whereas, Rishi MS Institute of Engineering and Technology for Women(RMSIETW) and Rishi UBR Women's College (RUBRCW)** are leading institutions where innovation, excellence, and holistic education shape the leaders of tomorrow. Nestled in the vibrant city of Hyderabad, India, RUBRCW stands as a beacon of educational advancement for women, committed to fostering an environment where students thrive intellectually, socially, and professionally. With a strong emphasis on academic rigor, research-driven learning, and global engagement, RMSIETW and RUBRCW combined offers a diverse range of programs spanning across disciplines, catering to the evolving needs of the 21st-century workforce in Engineering, B. Com (Computer Application), B.Sc., and BBA.

Both parties agree to treat any confidential information shared during the collaboration with utmost care and not to disclose such information to third parties without prior written consent. The provisions of this Clause 3 shall be binding upon the parties upon the signing of this MOU, and shall survive the termination or expiry of this MOU.

#### 4. Validity and Termination

This MoU shall be valid from the date of signing and remain in effect until the successful execution of the agreed activities or until mutually terminated by both parties in writing. Further either party may terminate the MOU by notifying the other party in writing with 30 days prior notice.

#### 5. Dispute Resolution

Any dispute arising out of the interpretation or implementation of this MOU shall be resolved amicably through mutual consultation and negotiation between the parties. In the event of any dispute, both the parties shall jointly engage in dialogue, in a spirit of mutual respect and cooperation, to resolve the matter to the satisfaction of both the Parties.

#### 6. Amendment

Both parties agree that this MOU may be amended any time through mutual written consent, with a notice period of 30 days. Neither party shall assign any rights or obligations under this MOU, in whole or in part, to any person or entity without prior written consent of the other party.
